$3^{\text {rd }}$ quarter of 2019

## The unemployment rate decreased to 6.1\%

In the $3^{\text {rd }}$ quarter of 2019, the unemployment rate ${ }^{1}$ stood at $6.1 \%$, the lowest value of the data series started in 2011. That value is 0.2 percentage points ( pp ) lower than the one from the previous quarter and 0.6 pp lower than that of the same quarter of the previous year.

The unemployed population, estimated at 323.4 thousand people, has decreased by $1.5 \%$ ( 5.1 thousand) from the previous quarter and by $8.3 \%$ (29.3 thousand) from the same quarter of 2018.

The employed population (4,947.8 thousand people) recorded a quarterly increase of $0.6 \%$ ( 31.1 thousand) and a year-on-year increase of $0.9 \%$ ( 45.0 thousand).

The youth ( 15 to 24 years old) unemployment rate stood at $17.9 \%$ and has decreased by 0.2 pp from the previous quarter and by 2.1 pp from the same quarter of the previous year. The share of unemployed people looking for a job for 12 months or longer (long-term unemployment) was $52.4 \%$, down 0.7 pp from the previous quarter and up 2.4 pp from the same quarter of the previous year.

## 1. Labour force (active population)

The Labour Force Survey results for the $3^{\text {rd }}$ quarter of 2019 indicate that the labour force (active population), $5,271.2$ thousand people, increased by $0.5 \%$ ( 26.1 thousand) from the previous quarter and by $0.3 \%$ (15.7 thousand) from the same quarter of 2018.

The participation rate of the working age population (15 years old and over) stood at $59.5 \%$, having increased by 0.3 percentage points (pp) from the previous quarter and by 0.1 pp from the same quarter of 2018.

[^0]The participation rate of men (64.9\%) was 10.2 pp higher than that of women (54.7\%) and it has increased by 0.8 pp from the previous quarter and by 0.4 pp in the year-on-year comparison, while the participation rate of women has decreased by 0.2 pp from both periods under comparison.

## 2. Employed population

### 2.1. Quarterly changes

The employed population ( $4,947.8$ thousand people) increased by $0.6 \%$ ( 31.1 thousand), in line with the pattern observed in the third quarters since the $3^{\text {rd }}$ quarter 2016 inclusive.

That change was explained by the increases recorded mainly in the following groups: men (45.0 thousand; $1.8 \%$ ); people aged 45 to 64 ( 30.6 thousand; 1.4\%) and 15 to 24 ( 24.5 thousand; $8.3 \%$ ); having completed the (upper) secondary and post-secondary non-tertiary education ( 65.6 thousand; $4.7 \%$ ); employed in the services sector ( 27.9 thousand; $0.8 \%$ ) - mainly in the activities of accommodation and food services (14.5 thousand; 4.6\%) and of arts, entertainment and recreation ( 15.4 thousand; 24.6\%); as employees ( 42.9 thousand; 1.1\%), with a permanent contract (53.4 thousand; 1.7\%); and working full-time (59.5 thousand; 1.4\%).


The employment rate ( 15 years old and over) stood at $55.8 \%$ and increased by 0.3 pp from the previous quarter.

The employment rate of men (61.4\%) exceeded that of women ( $51.0 \%$ ) by 10.4 pp . The former increased by 1.1 pp while the latter decreased by 0.3 pp from the $2^{\text {nd }}$ quarter 2019.


### 2.2. Year-on-year changes

From the same quarter of 2018, the employed population increased by $0.9 \%$ ( 45.0 thousand), extending the series of positive year-on-year changes observed since the $4^{\text {th }}$ quarter of 2013, although at a slower pace since the $1^{\text {st }}$ quarter of 2018.


The year-on-year increase in the employed population came mostly from the employment increase in the following groups: men ( 37.2 thousand; 1.5\%); people aged 45 to 64 ( 46.3 thousand; 2.2\%); having completed the (upper) secondary and post-secondary
non-tertiary education (108.3 thousand; 8.1\%); employed in the services sector ( 74.2 thousand; 2.2\%) - especially in the activities of human health and social work activities (42.0 thousand; 9.4\%); as employees ( 36.8 thousand; $0.9 \%$ ), with a permanent contract (99.5 thousand; 3.1\%); and working full-time (59.8 thousand; 1.4\%).

The employment rate ( 15 years old and over) increased by 0.4 pp from the same quarter of 2018, with the men's rate increasing by 0.9 pp while that of women remained unchanged.

## 3. Unemployed population

### 3.1. Quarterly changes

The unemployed population ( 323.4 thousand people) decreased by $1.5 \%$ ( 5.1 thousand) from the previous quarter.


The unemployed population reduction came from the decreases observed, mainly, in the following groups: men (10.3 thousand; 6.7\%); people aged 45 and over
(10.5 thousand; 7.8\%); who have completed, at most, the first or second stages of basic education (10.7 thousand; 6.9\%) or the (upper) secondary and post-secondary non-tertiary education (12.3 thousand; 11.2\%); looking for a new job (12.3 thousand; 4.1\%), having been formerly mainly in the services sector (10.0 thousand; 5.0\%); and seeking a job for 12 months or longer ( 5.1 thousand; 3.0\%).


The unemployment rate for the $3^{\text {rd }}$ quarter of 2019 decreased to $6.1 \%$, the lowest rate of the data series started in 2011. From the previous quarter, it decreased by 0.2 pp .

The unemployment rate of men (5.4\%) was lower than that of women (6.9\%) by 1.5 pp , having the former decreased by 0.5 pp from the previous quarter and the latter increased by 0.2 pp .

The youth ( 15 to 24 years old) unemployment rate was 17.9\%, down 0.2 pp from the previous quarter.

The share of unemployed people looking for a job for 12 months or longer (long-term unemployment) was 52.4\%, down 0.7 pp from the $2^{\text {nd }}$ quarter of 2019.

### 3.2. Year-on-year changes

From the same quarter of 2018, the unemployed population decreased by $8.3 \%$ (29.3 thousand), expanding the sequence of decreases observed since the $3^{\text {rd }}$ quarter of 2013.


That unemployed population decrease was explained mainly by the decreases recorded in the following groups: both men and women, but more for the former (20.0 thousand; 12.2\%); all age groups under analysis, in particular those aged 35 to 44 (13.9 thousand; $17.8 \%$ ); people having completed the (upper) secondary and post-secondary non-tertiary education (23.5 thousand; 19.4\%); looking for a new job (17.3 thousand; 5.7\%), having been formerly in the services sector ( 13.8 thousand; $6.7 \%$ ); and seeking a job for less than 12 months ( 22.2 thousand; 12.6\%).

From the same quarter of 2018, the unemployment rate decreased by 0.6 pp , being that reduction larger for men ( 0.8 pp ) than for women ( 0.3 pp ).

The unemployment rate of young people aged 15 to 24 decreased by 2.1 pp and the share of unemployed
people looking for a job for 12 months or longer (long-term unemployment) increased by 2.4 pp .

## 4. Inactive population

The inactive population, estimated in 4,989.9 thousand people in the $3^{\text {rd }}$ quarter of 2019, decreased by $0.5 \%$ (27.3 thousand) from the previous quarter and by $0.3 \%$ (15.7 thousand) from the same quarter of 2018.

The inactive population aged 15 and over (3,592.4 thousand people, accounting for $72.0 \%$ of total inactive population) has decreased by $0.7 \%$ from the previous quarter ( 24.0 thousand) and by $0.1 \%$ from the $3^{\text {rd }}$ quarter of 2018 ( 3.8 thousand).

The inactivity rate ( 15 years old and over) was $40.5 \%$, having decreased by 0.3 pp from the previous quarter and by 0.1 pp from the same period of 2018.

The inactivity rate of women (45.3\%) exceeded that of men ( $35.1 \%$ ) by 10.2 pp . From the previous quarter, the former has increased by 0.2 pp while the latter has decreased by 0.8 pp . The same pattern was observed from the year-on-year period with the inactivity rate of women increasing by 0.2 pp while that of men has decreased by 0.4 pp .

Figure 7 exhibits a summary of the observed changes in this quarter (quarterly and year-on-year) by labour market status, as described in items 1 to 4 of this Press Release.


## 5. Quarterly flows between labour market states

### 5.1. Gross and net flows (number of persons)

## Employment

From the $2^{\text {nd }}$ to the $3^{\text {rd }}$ quarter of 2019, 70.2 thousand persons moved from employment (E) to unemployment (U) and 167.6 thousand moved from employment to inactivity (aged 15 and over; I). The number of persons moving out of employment, within a quarter, was then 237.7 thousand.

At the same time, the employment inflows from unemployment were 85.4 thousand persons, while those from inactivity were 183.4 thousand. The number of persons moving into employment, within a quarter, was 268.8 thousand.

As a consequence, between the two quarters there was a positive net flow into employment (that is, total inflows minus total outflows) of 31.1 thousand persons (which correspond to the employed population quarterly change).

## Unemployment

On the other hand, the net flow into unemployment was negative and comprised 5.1 thousand people (which corresponds to the unemployed population quarterly change), and resulted from the total of people becoming unemployed ( 151.1 thousand) being lower than the total of those leaving that status (156.1 thousand).

The unemployment inflows from employment ( 70.2 thousand) were smaller than those from inactivity ( 80.9 thousand). On the other hand, the unemployment outflows to employment ( 85.4 thousand) were larger than those to inactivity ( 70.7 thousand).

The next figures exhibit the quarterly developments of the net employment and unemployment flows, from the $3^{\text {rd }}$ quarter of 2011 onwards, and their decomposition into the two components that explain them: net flows between employment and unemployment and net flows between employment and inactivity (Figure 8); net flows between unemployment and employment and net flows between unemployment and inactivity (Figure 9).

From these estimates analysis, it is possible to conclude, for the $3^{\text {rd }}$ quarter 2019, that:

- The employment quarterly increase (31.1 thousand) resulted from the positive net flow between employment and both unemployment (15.3 thousand) and inactivity (15.8 thousand).
- The unemployment decrease between quarters (5.1 thousand) was explained by the negative net flow between employment and inactivity (15.3 thousand) having more than compensated
the positive net flow between unemployment and inactivity (10.2 thousand).


### 5.2. Transition rates (\%)

From the $2^{\text {nd }}$ to the $3^{\text {rd }}$ quarter of 2019, $1.4 \%$ of the people initially employed moved into unemployment and $3.4 \%$ moved into inactivity, with the proportion of employed moving out of this situation totalling $4.8 \%$ in the $3^{\text {rd }}$ quarter of 2019 ( $95.2 \%$ remained employed; which corresponds to $4,679.0$ thousand people, as in Diagram 1).

## Diagram 2: Quarterly flows between labour force status (as a \% of initial state)



From the total of unemployed persons in the $2^{\text {nd }}$ quarter of 2019, 47.5\% moved out of this labour market state in the $3^{\text {rd }}$ quarter of 2019: $26.0 \%$ became employed and $21.5 \%$ moved into inactivity.

From the total of people aged 15 and over considered to be inactive in the $2^{\text {nd }}$ quarter of $2019,5.1 \%$ moved into employment and $2.2 \%$ moved into unemployment in the $3^{\text {rd }}$ quarter of 2019.

## 6. Unemployment rates by NUTS II region

In the $3^{\text {rd }}$ quarter of 2019, the unemployment rate was higher than the national average in five NUTS II regions of the country: Região Autónoma dos Açores (7.3\%), Alentejo (7.0\%), Região Autónoma da Madeira (6.9\%), Norte (6.6\%), and Área Metropolitana de Lisboa (6.4\%).

The unemployment rate of no Algarve (5.3\%) and Centro (4.8\%) stood below that value (6.1\%).

Compared to the previous quarter, the unemployment rate has decreased in Algarve (1.4 pp), Região Autónoma dos Açores ( 0.9 pp ) and Área Metropolitana de Lisboa ( 0.7 pp ), remained unchanged in Região Autónoma da Madeira and has increased in Norte ( 0.4 pp ), Centro and Alentejo ( 0.1 pp in both regions).

Compared to the same quarter of 2018, the unemployment rate has increased in Alentejo ( 0.4 pp ) and A/garve ( 0.3 pp ), while having decreased in the remaining regions. The two largest year-on-year decreases were observed in Região Autónoma da Madeira ( 2.0 pp ) and in Região Autónoma dos Açores (1.4 pp).

## 7. Supplementary indicators to unemployment and the labour underutilisation

In the $3^{\text {rd }}$ quarter of 2019, the labour underutilization was estimated at 667.7 thousand people and the corresponding rate was $12.2 \%$.

The labour underutilisation decreased by 1.3\% ( 8.8 thousand) from the previous quarter and by $6.9 \%$ (49.8 thousand) from the previous year. By component, the following is observed:

- The unemployed population was estimated at 323.4 thousand people and, as previously mentioned, decreased by $1.5 \%$ ( 5.1 thousand) from the previous quarter and by $8.3 \%$ ( 29.3 thousand) from the same quarter of 2018. The unemployment rate was $6.1 \%$, down 0.2 pp from the previous quarter and down 0.6 pp from the $3^{\text {rd }}$ quarter of 2018.
- The number of underemployed part-time workers affected 141.5 thousand people, 10.4\% (16.4 thousand) less than in the previous quarter and $5.8 \%$ ( 8.7 thousand) less than in the same quarter of 2018.
- The number of inactive persons seeking work but not immediately available (23.0 thousand) has increased by $5.0 \%$ ( 1.1 thousand) from the $2^{\text {nd }}$ quarter of 2019, while remaining practically unchanged from the $3^{\text {rd }}$ quarter of 2018.
- The number of inactive persons available to work but not seeking (179.7 thousand) increased by $6.8 \%$ ( 11.5 thousand) from the previous quarter and decreased by 5.9\% (11.3 thousand) from the same quarter of 2018.

The quarterly decrease of both the unemployed population and the labour underutilisation in the $3^{\text {rd }}$ quarter of 2019 follows the downwards trend observed since the $1^{\text {st }}$ quarter of 2013, having decreased in total $65.1 \%$ and $54.6 \%$, respectively (corresponding to 603.4 thousand and 801.9 thousand people in each case). These reductions were also observed in the correspondent rates, having the unemployment rate dropped from $17.5 \%$ to $6.1 \%$ and the labour underutilisation rate from $26.4 \%$ to $12.2 \%$.

## 8. Young people not in employment, education or training

In the $3^{\text {rd }}$ quarter of 2019, from the total of 2,198.8 thousand young people (aged 15 to 34), 10.0\% (220.2 thousand) were not in employment, education or training.

From the previous quarter, the rate of young people not in employment, education or training increased by 1.3 pp (29.3 thousand). This growth resulted from an increase for women ( 33.7 thousand; 3.2 pp ) that more than compensated the slight increase for men ( 4.5 thousand; 0.4 pp ). The rate increase was also followed by increases in all age groups, especially among those aged 25 to 34 (11.8 thousand; 1.1 pp ).


In the $3^{\text {rd }}$ quarter of 2019, the rate of young people not in employment, education or training has increased by 0.1 pp (which corresponds to a nearly null absolute change), in result of the increase in women (10.9 thousand; 1.1 pp ) having compensated the decrease in men ( 10.1 thousand; 0.8 pp ). The rate
increase was also observed in the age group 20 to 24
(4.5 thousand; 0.6 pp ).

## TECHNICAL NOTE

The main purpose of the Labour Force Survey is to characterise the population in terms of the labour market. It is a quarterly sample survey, addressed to families occupying the same dwelling in the national territory, which makes available quarterly and annual data.

Most of the characteristics observed in this survey report to the situation in one pre-defined week (from Monday to Sunday), known as reference week. The reference weeks are uniformly distributed throughout the quarters and years. The interviews usually take place in the week following the reference week.
The information is obtained directly, through computer-assisted interview, by using a mixed data collection mode: the initial interview is done face-to-face by an interviewer visiting the household and the other five interviews are done by telephone, if certain requirements are met.

Published data were calibrated by using the population estimates calculated from the final results of Census 2011. Due to rounding, the totals in tables and diagrams do not always match the sum of parts.
For more detailed information consult the Labour Force Survey methodological document (only in Portuguese) available at the Statistics Portugal website.

## Some concepts

Unemployed: person aged 15 and 74 who, during the reference period, was simultaneously in the following situations:

- without work, i.e. was not in paid employment or self-employment;
- seeking work, i.e. had taken specific steps in a specified recent period (reference period or the three previous weeks) to seek paid employment or self-employment; and
- currently available for work, i.e. was available for paid employment or self-employment during the reference period.

Employed: person aged 15 and over who, during the reference period, was in one of the following situations:

- did any work for pay or profit for at least one hour, including a familiar gain in money or gender;
- was not working but had jobs from which was temporarily absent;
- had a business, but was temporarily not working for a specific reason;
- was in a pre-retirement situation while working.

Labour force (active population): all persons aged 15 or over who, during the reference period, made up the available labour force for the production of economic goods and services (employed and unemployed).

Extended labour force: labour force enlarged by the inactive seeking work but not immediately available and the inactive available but not seeking work.

Labour underutilisation: indicator that aggregates the unemployed population, the underemployment of part-time workers, the inactive seeking work but not immediately available, and the inactive available but not seeking work.
Young people not in employment, education or training: population of young people of a given age group that, in the reference period, was not employed (i.e., was unemployed or inactive) and was not involved in education or training over a specific period of time (the reference week or in the previous three weeks).
Participation rate: ratio between the labour force and the total population.
P.R. (\%) = (Labour force / Total population) $\times 100$

Participation rate ( 15 and over): ratio between the labour force and the working age total population ( 15 and over).
P.R. (\%) $=($ Labour force $/$ Total population 15 and over $) \times 100$

Employment rate ( $\mathbf{1 5}$ and over): ratio between the employed population and the working age total population (15 and over).
E.R. (\%) $=($ Employed population $/$ Total population 15 and over $) \times 100$

Unemployment rate: ratio between the unemployed population and the labour force.
U.R. (\%) $=$ (Unemployed population / Labour force) $\times 100$

Long term unemployment rate: ratio between the unemployed population seeking employment for 12 months and over and the labour force.
L.T.U.R. (\%) = (Unemployed population seeking employment for 12 months and over / Labour force) $\times 100$

Inactivity rate ( $\mathbf{1 5}$ and over): ratio between the working age inactive population ( 15 and over) and the working age total population (15 and over).
I.R. (\%) = (Inactive population 15 and over / Total population 15 and over) $\times 100$

Labour underutilisation rate: ratio that defines the relationship among the labour underutilisation and the extended labour force.
L.U.R. (\%) $=($ Labour underutilisation / Extended labour force) $\times 100$

Rate of young people not in employment, education or training: ratio between the population of young people of a given age group not in employment, education or training and the total population of young people of the same age group.

## On year rate of change

The in year (year-on-year) change compares the level of the variable in the current quarter with that of the corresponding quarter of the previous year. This rate of change, considering a seasonal stable pattern is not affected by this type of fluctuation, but may, however, be influenced by specific effects in a given quarter.

## On quarter rate of change

The in quarter (quarterly) change compares the level of the variable over two consecutive periods. Although this indicator permits to monitor the recent pace of the variable, its calculation is particularly influenced by seasonal effects and other more specific effects in one (or both) quarters under comparison.

## Annual rate of change

The annual change compares the average level of the variable for the four quarters of the last year over the average level of the variable for the four quarters of the previous year. Being an average, this indicator is less sensible to sporadic effects in the variable.

[^0]:    ${ }^{1}$ This unemployment rate was calculated for those aged 15 and over (in line with the concepts in force of the International Labour Organization). The unemployment rate for the moving quarter centred in August 2019 (which corresponds to the $3^{\text {rd }}$ quarter 2019) published in the Press Release of September 2019 (released in 30-10-2019), was calculated for the age subgroup of those aged 15 to 74 (as in the Eurostat News Release). This rate (not seasonally adjusted) was 6.2\%.
